



Fully Vaccinated

3

Fully Vaccinated Individual

- All required doses
- At least two weeks since final dose
- Symptom free

Visitors

5

General Requirements

- Screen for symptoms/exposure
- Face covering
- Hand hygiene upon entering
- Physical distancing

In Room Visitation

- Licensees should allow indoor visitation, including in-room visitation, at all times and for all residents, regardless of vaccination status of the resident or visitor

Exceptions

- Residents with confirmed COVID-19
- Residents quarantined
- Essential visits allowed

Physical Touch

- Fully vaccinated visitors of fully vaccinated residents
- Still wear a face covering
- Visitor must present vaccine card

Essential Visits

- Should not be suspended
- Medically necessary
- Compassionate care
- DSS, health department, etc
- Service contractors

Compassionate Care Visits

- End-of-life
- A resident who was recently admitted and is struggling with the change in environment and lack of in-person family support
- A resident who is grieving after a friend or family member recently died
- A resident who needs cueing and encouragement with eating or drinking, previously provided by family and/or caregiver(s), and is experiencing weight loss or dehydration
- A resident who used to talk and interact with others is experiencing progressive withdrawal, emotional distress, seldom speaking, behavioral decompensation, or crying more frequently

Best Practices

- Manage size, frequency, and duration
- Manage entrances/exits
- Increase ventilation
- Limit movement
- Signage
- Testing
- Shared rooms

Dining, Activities, Outings

Dining

- May eat at the same table
- Hand hygiene
- Face coverings when not eating/drinking
- Consider creating dining groups to minimize exposure

Activities

- Physical distancing
- 10 person limit no longer in the recommendation

Outings

- Residents have the right to leave facilities for outings such as holiday celebrations, private gatherings, or extended or overnight stays with family
- Provide education
- Screen upon return

Returning From an Outing

Screening	Action
Had close contact with a person who is positive for COVID-19	Quarantine
Did not have close contact to someone who tested positive for COVID-19,	No quarantine

New Move Ins

- New admissions that are fully vaccinated do not need to be quarantined if they have not had close contact with someone with COVID-19 in the prior 14 days
- New admissions who are not fully vaccinated should follow the quarantine recommendations in PIN 21-12-ASC
